- That the school authority shall provide retirement benefits to the 3. teaching and non-teaching staff of the school as per Death-cum-Retirement Benefit Scheme.
- That the Managing Committee of the school shall be constituted with at-4. least three guardian members, three elected teacher members and one non-teaching staff. The Principal will be an Ex-officio member of the Managing Committee.
- That the school authority shall not enhance tuition fees or other charges 5. (a) without prior permission of the competent authority.
 - That the school shall not charge any capitation fee or equivalent to (b) capitation fee by any means.
- That the recruitment of teachers shall be done in accordance with 6. transparent merit-based criteria as laid down in the Memorandum of parent Body and information thereof shall be made available to the State Government, if necessary.
- That the funds raised by the school authority, the fees collected and 7. earned income by any other source, shall not be utilized for any other purpose than the welfare of the school and benefit of education of the students and the teaching and non-teaching staff of the school.
- That no change in the ownership of the school or handing over of 8. property or management of the school shall be done by any manner. Changing or amending the character of the Parent Body shall not be done without prior notice to the State Government.
- That service of teaching and non-teaching staff shall not be terminated 9. without giving opportunity of being heard by the Competent Authority and without observing due disciplinary proceedings.

- That the service condition of the teaching and non-teaching staff including provisions of security of service, disciplinary proceedings and procedure for Appeal shall be implemented in accordance with the directions laid down in the Memorandum of the Parent Body and submitted to the State Government.
- The school shall abide by procedure and rules and legal provision that 11. may be promulgated in this regard.
- The school will be its teaching and non-teaching staff emoluments at a 12. rate which should not be less than those of their counterparts with equivalent educational qualifications in the State-aided Educational Institutions.
- The school will provide for Contributory Provident Fund for the 13. employees as prescribed under the relevant Provident Fund Act/rules of the Government of India.
- 10% (ten percent) of the new admission in the school in each academic 14. year will be allowed on the recommendation of the School Education Department and 50% of each student will have to be allowed to prosecute studies in the school free of any cost.
- The school have to furnish accurate and up-to-date statistical 15. information relating to the functioning of the school and its academic activities as and when the same is called for by the Deputy Director of School Education (AIS), West Bengal.
